RESOLUTION TO ESTABLISH
COUNTY SERVICE AREA NO. 34

WHEREAS, The Board of Supervisors of the County of San Benito, State of California ("County") hereby resolves, pursuant to Government Code Section 25210.15 that County Service Area No 34 is established, pursuant to the County Service Area Law, as set forth in Government Code Section 25210 et seq.

WHEREAS, The County Service Area No. 34 is located in the unincorporated area of the County of San Benito, on Comstock Road and shown further in Exhibit "A", attached hereto and incorporated herein by reference.

WHEREAS, The type or types of extended County services proposed to be provided within said service area pursuant to the Government Code Section cited herein, are as follows:


- 1) Maintenance and operation of storm and drainage facilities.
- 2) Water system facility services.
- 3) Street lighting, street maintenance street signs.
- 4) Street sweeping and landscaping maintenance.

The County shall fix and collect charges for such services pursuant to Government Code Section 25210.77 (a) to pay, in whole or in part, for the costs of providing such services. The revenue obtained by such charges be in lieu or of supplemental to revenue obtained by the levy of taxes within such area.



A Resolution of the San Benito County Board of Supervisors

Resolution No. 92-102

A RESOLUTION ESTABLISHING COUNTY SERVICE AREA NUMBER 38.

WHEREAS, Resolution No. 92-3 of the San Benito County Local Agency Formation Commission authorized proceedings for the formation of County Service Area No. 38.

WHEREAS, Resolution No. 92-91 of the San Benito County Board of Supervisors expressed the Board's intent to establish this County Service Area.

WHEREAS, the San Benito County Board of Supervisors held a noticed public hearing on this matter on September 1, 1992.

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of the County of San Benito makes the following determinations:

1. The County Service Area is designated Number 38.
2. Without election, finally determines and establishes the boundaries of the County Service Area as those shown in attached Exhibit A.
3. The types of services to be performed by the County Service Area shall be as follows:
maintenance of street lighting, water systems, drainage facilities,
streets, recreation facilities, landscaping and street sweeping.
